GUIDELINES FOR THE USE OF EQUIPPED PUBLIC BEACH WITH COMPULSORY BOOKING

- The term "equipped public beach" refers to any marine state property concessions which provide bathing services directly or entrusted to third parties. Equipped public beach has free and open access.
- 2. The use of "equipped public beach" with compulsory booking procedures, includes the following: a) Use of a 16-square-metre pitch with a central numbered pole as placeholder; b) Use of toilets and showers; c) Welcome service provided by the concession holder.
- 3. Everyone who uses the "equipped public beach" (see point no. 2) must declare and agree that they have read at the time of booking. That they are aware of the terms and conditions, and accept these guidelines with no exception (the guidelines can be downloaded on the institutional website www.comune.jesolo.ve.it)
- 4. The duration of daily bookings is subject to the punctual respect of the mentioned conditions in the present guidelines by the user. It is agreed that the violation of any one of the stated conditions in these guidelines gives the right to the concession holder to withdraw the provision of services, with consequent loss of the booked pitch for the user.
- 5. The user must keep the booking receipt, either electronically or on paper as confirmation to show certification to his/her right in the use of the services of the equipped public beach. This confirmation can be requested by the staff responsible for inspection at any time during the booking period.
- 6. No temporal displacements, transfers or changes of the daily booking are accepted for any reason (change of mind, bad weather, high tide, sea storms, natural disasters, etc.). To confirm, the booking is only valid for the actual day/date it refers to.
- 7. Changing the reservation and allocated pitch is not allowed.
- 8. It is not permitted to occupy a place in the "equipped public beach" without a formal electronic assignment upon reservation. The access to the equipped public beach areas is subject to availability.
- 9. In order to preserve the area of the surrounding pitches it is forbidden to move Deckchairs, sunbeds and beach towels from the assigned place.
- 10. Every pitch can accommodate people in one of the following ways:
 - Kinsmen users: 2 adults + 3 children under 14 years old (in addition to any babies);
 - Kinsmen users: 4 adults + 1 child under 14 years old (in addition to any babies);
 - No kinsmen users: 4 adults or adults and children (in addition to any babies).

It is highly recommended that you should not exceed the above-mentioned numbers in order to avoid social gatherings.

It is highly recommended that you strictly respect the social distancing procedures in accordance with the current national, regional and local laws when reaching and during your time in the assigned pitch.

- 11. When completing the online reservation, you will be requested to provide either the tax code or a document number of the person who makes the reservation.
 - The person who makes the reservation is responsible for completion of the reservation and for the other people included in that specific reservation.
- 12. The reservation is daily and it can be made one day at a time. Reservations for every day can be made from the day before, until full capacity is reached.

The reservation can be cancelled.

- The access is allowed from the opening time of the equipped public beach, following the timetable of the bathing establishment.
- 13. Inappropriate behaviour which disturbs other users is totally forbidden. In this case, immediate dismissal from the beach will take place and possible risk of escalation of complaint to the public security authority.
- 14. The booking system reserves the right to not accept reservations by people or family units who represent improper or damaging behaviour to third parties.
- 15. The concession holder has the right to assign another pitch under exceptional circumstances for public interest and safety.
- 16. Users of the "equipped public beach" can use communal facilities (especially toilets and showers) but are requested to use with respect and promptly notify the concession holder of any malfunction of the facilities. Users will be required to compensate towards any damage caused by intent or fault to the equipment in common use.
- 17. The concession holder takes no responsibility for objects and/or materials owned by beach users in case of damage or theft inside or outside the equipped public beach. It is recommended not to leave money, values, clothes, toys, mattresses and any other personal items unattended.
- 18. Social entertainment, sports activities and team games that cause large gatherings and affect social distancing are not allowed.
- 19. In equipped public beaches it is forbidden to take any animals of whatever species even though they are equipped with muzzle and leash with the exception of guide dogs for visually impaired users (see dedicated free area on the ordinance no. 69 28th June, 2016).

- 20. It is forbidden to move within the equipped public areas by bike or other means of transport that can cause damage to people.
- 21. Toilets, sinks and showers must be kept tidy and clean. Users are not allowed to use shampoo and shower gel when they use showers on the beach.
- 22. On strong windy days sun umbrellas also private ones must be kept closed.
- 23. You are kindly asked to remain within the standard distance of the lifeguard tower. It is forbidden to approach/sit on the lifeboats and to maintain the requested distance of the lifeguard tower.
- 24. The user must observe and understand the provisions of these stated guidelines, stipulated by the Authority of the Municipality of Jesolo and the Shipping Circumlocution Office Coast Guard of Jesolo, for the use of the maritime domain and of the municipal regulation for the use of public beaches and equipped public beaches. For further information documents are displayed at the entrance of the equipped public beach.
 - Non-compliance with the rules will result in immediate eviction from the beach for the offender.
- 25. In the booking system the part "self-certification Covid-19" must be inserted. The user declares that they are not (now or previous) infected by Covid-19 and agrees to take all preventive measures, also in accordance with guidelines and instructions by the WHO and by the national Health Authority, aimed at preventing the spread of Covid-19.
 - Besides, the user declares that:
 - he/she has not been (or is not aware to have been) in close contact with someone affected by Covid-19;
 - he/she did not receive any communication by competent authorities about a close contact with someone affected by Covid-19;
 - he/she has not had any of the following symptoms in the last 15 days: fever over 99,5 F, cough, worsening of health conditions.
 - The content of self-certification must be true for the whole period of stay on the free equipped beach.
- 26. For further points not stated within the above guidelines, we ask you kindly to refer to the current Municipal Ordinance Discipline of Beach Activities.
- 27. In accordance with current legislation on privacy, information according to article 13, EU Regulation 2016/679 (General Data Protection Regulation EU-GDPR) may be consulted on website http://www.Jbeach.app
